

### Results interpretation:

- "Invalid" result might be caused by but not limited to inappropriate sampling, storage, transport and low nucleic acid concentration etc, the client therefore needs to be sampled again for screening.  
若篩查結果為無效，可能原因包括且不僅限於不合理採樣、保存和運輸、樣本濃度過低等，需要重新採樣篩查。
- "Negative" result suggests no COVID-19 nucleic acid is found. Please take COVID-19 nucleic acid screening again if respiratory infections symptoms (like fever, cough etc) appear later.  
若篩查結果為陰性，說明樣本未發現新型冠狀病毒核酸分子。如之後有發燒、咳嗽等症狀發生，建議再次做核酸分子篩查。
- "Suspected" result is highly recommended to be screened again by COVID-19 nucleic acid screening, as well as IgM and IgG antibody screening.  
若篩查結果為疑似，建議用核酸及IgM和IgG抗體篩查組合進行再次確認。
- "Positive" result is highly recommended to do IgM and IgG antibody screening for confirmation, and seek professionals' (doctors') help immediately.  
若篩查結果為陽性，建議用IgM及IgG抗體篩查做再次確認，同時建議立即諮詢醫生及相關醫療人員。
